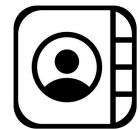

# Terms & Conditions



These terms govern the services provided by **Aditya Web Lab**. By proceeding with our services, you agree to the terms outlined below, ensuring clarity and mutual understanding.

## + Payment Terms

A project-based payment method will be followed. Payment is divided into two installments:

- **50% upfront:** Due before the commencement of work.
- **50% upon completion:** The remaining balance is due once the final project is delivered and approved.

No hourly payments will be accepted.

## + Revision Policy

Each plan includes a set number of free revisions:

- **Starter:** 1 revision included.
- **Standard:** 2 revisions included.
- **Advanced:** 3 revisions included.
- **Platinum:** 5 revisions included.

Any additional revisions beyond those included in the package will be billed at **\$30 per hour**.

Revisions should be requested within 3 days of each project milestone delivery. Requests made after this timeframe may extend the project timeline.

## + Project Timeline

The estimated timeline for project completion is based on the selected plan:

- **Starter:** 1-2 weeks.
- **Standard:** 3-4 weeks.
- **Advanced:** 4-6 weeks.
- **Platinum:** 7-8 weeks.

The timeline may extend if delays in client feedback or asset delivery occur.

## + Ownership & Deliverables

Upon full payment, the client will own all rights to the final website, including design files, code, and content.

Deliverables will include:

- A fully functional website as per the agreed-upon scope.
- Access to the content management system (CMS), if applicable.
- Any necessary files (e.g., design mockups, source code) provided upon request.

Until full payment is made, all deliverables and project materials remain the intellectual property of [Aditya Web Lab].

## + Scope Of Work

The services provided under each plan include everything outlined in the selected package. Any additional features or requests beyond the plan's scope will be considered **out of scope** and will incur additional charges at **\$45 per hour**.

## + Cancellation Policy

- **Client-Initiated Cancellation:** If the client is unsatisfied with the work, a **100% refund** is available if requested within **14 days of project completion**.
- **Provider-Initiated Cancellation:** If I am unable to deliver the project for any reason, the client will receive a **100% refund**.

## + Post-Launch Support

All packages include **2 weeks of free support** for minor bugs and fixes post-launch. After this period, ongoing maintenance or additional support will be available at a rate of **\$100 per month**.

## + Termination Clause

Either party may terminate this agreement under the following conditions:

- **Client-Initiated Termination:** The client may terminate the project at any time. If the project is terminated **before completion** and the client is unsatisfied with the work, they are eligible for a **100% refund** if requested within **14 days** of the project's completion. However, if the project is terminated during the development phase and substantial work has been completed, no refund will be issued for the upfront payment.
- **Provider-Initiated Termination:** In the unlikely event that I am unable to deliver the project due to unforeseen circumstances, the client will receive a **100% refund**, including the upfront payment.
- **Material Breach:** Either party may terminate the agreement if the other party fails to meet its contractual obligations, including but not limited to failure to provide required assets or feedback in a timely manner. In such cases, the client will be responsible for paying for any work completed up until the date of termination.

Termination must be communicated in writing, and any refund requests must be processed within 14 days of termination.

## + Client Responsibilities

To ensure the smooth and timely execution of the project, the client is responsible for:

- Providing all necessary content, images, and copy for the website.
- Delivering timely feedback at each project milestone.
- Supplying any required assets (e.g., branding guidelines, logos) within 2 days of the request.

Any delays in providing the required assets or feedback may result in extensions to the project timeline.

## + Confidentiality

Both parties agree to maintain the confidentiality of any proprietary or sensitive information shared during the course of this project. This includes, but is not limited to, trade secrets, client data, and business information. Neither party will disclose such information to any third party without prior written consent.

## **+ Liability Limitation**

While every effort will be made to ensure the website is secure and error-free, I am not liable for any indirect, incidental, or consequential damages resulting from the use or performance of the website. It is the client's responsibility to maintain backups of all content and data related to the website.

## **+ Acceptance of Terms**

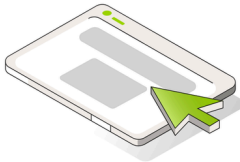

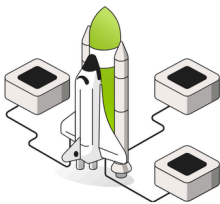

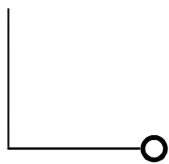
